

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Recognition of Relinquishment from membership in the Tohono O'odham
Nation for the month of June 2023)**

RESOLUTION NO. 23-205

1 **WHEREAS, Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation vests the**
2 **Tohono O'odham Legislative Council with the power to "enact laws and**
3 **ordinances governing the enrollment and adoption of members and the**
4 **relinquishment and loss of membership"; and**

5 **WHEREAS, in accordance with the Tohono O'odham Nation's Enrollment Ordinance,**
6 **Ordinance No. 05-81 as amended the Enrollment Committee has received a**
7 **written statement from 01 tribal member who has expressed their intent to**
8 **relinquish their membership with the Tohono O'odham Nation and the members**
9 **are identified in the June 2023 Relinquishment List, which is incorporated by this**
10 **reference; and**

11 **WHEREAS, pursuant to Article IX Section 1 of the Enrollment Ordinance,**

13 **A member of the Nation may relinquish his membership in the Nation by**
14 **submitting a written statement clearly expressing an intent to relinquish**
15 **his membership to the Council, a copy of which must be served on the**
16 **committee. The written statement must be signed by the person wishing**
17 **to relinquish his membership or, if a minor or incompetent, by the**
18 **parent(s), guardian or other person legally authorized to act on his behalf.**
19 **Relinquishment does not require the approval of the Council, but is**
20 **effective upon receipt of the statement by the Council and cannot be**
21 **subsequently denied. Upon recognition by the Council that the individual**
22 **has renounced his membership, his name shall be deleted from the**
23 **membership roll.**

25 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
26 **recognizes that one individual identified in the June 2023 Relinquishment List**
27 **has relinquished their membership in the Tohono O'odham Nation and orders**
28 **the removal of their name from the Nation's membership roll.**


