14		name changes of enrolled members as a result of marriage, divorce, legal
15		adoption, or for other reasons; and
16	WHEREAS,	the Enrollment Committee recommends that Resolution Nos. 32-80, 115-82, 83-
17		83, 98-83, 222-84, 910-85, 11-158, 13-431, 14-319, 17-579, and 18-425 be amended

19		Enrollment Resolution Summary, which is incorporated by this reference.
