RESOLUTION NO. 23-207

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to enact laws
2 and ordinances governing the enrollment and adoption of members
3 (Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and
4 Article VI, Section 1(h)); and

5 **WHEREAS,** pursuant to Articles VI and VII of the Nation's Enrollment Ordinance, the
6 Enrollment Committee shall review membership applications and make a
7 written recommendation to the Tohono O'odham Legislative Council to approve
8 or reject the application (14 Tohono O'odham Code Chapter 1 – Enrollment
9 Ordinance); and

10 **WHEREAS,** pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono
11 O'odham Legislative Council shall determine eligibility for membership or
12 adoption; and

13 **WHEREAS,** the Enrollment Program has determined that a number of resolutions approving
14 membership and adoption applications misspelled or incorrectly listed the
15 names of members and/or incorrectly listed enrollment numbers; and

16 **WHEREAS,** the Enrollment Committee recommends that Resolution Nos. 23-81, 2000-176, 02-
17 042, 02-129, 05-711, 06-002, 06-222, 07-007, 07-075, 07-500, 07-546, 07-739, 08-644,
18 09-101, and 18-061 be amended to reflect the correct names of members
19 identified in the June 2023 Corrected Enrollment Resolution Summary, which is
20 incorporated by this reference.

21 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that Resolution
22 Nos. 23-81, 2000-176, 02-042, 02-129, 05-711, 06-002, 06-222, 07-007, 07-075, 07-
23 500, 07-546, 07-739, 08-644, 09-101, and 18-061 are amended upon the effective
24 date of those resolutions to reflect the correct names of members identified in
25 the June 2023 Corrected Enrollment Resolution Summary.

26 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH
27 day of JUNE, 2023 at a meeting at which a quorum was present with a vote of 3,001,4 FOR;
28 ~~0~~ AGAINST; ~~0~~ NOT VOTING; and 216.6 [05] ABSENT, pursuant to the powers vested in the
29 Council by, Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the
30 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and
31 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,
32 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
