

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Amendments to Monthly Age 18 Reports for September 2012 and**  
**January 2014 Approved by Resolution Nos. 12-346 and 14-004 to Correct**  
**Names and/or Roll Numbers of Members)**

**RESOLUTION NO. 23-208**

1 **WHEREAS,** the Constitution of the Tohono O'odham Nation vests the Tohono O'odham  
2 Legislative Council with the power "to manage any funds within the exclusive  
3 control of the Tohono O'odham Nation . . . and to appropriate these funds for the  
4 benefit of the nation and its members" provided that "[a]ll expenditures of these  
5 funds shall be pursuant to appropriations or budgets" authorized by resolution  
6 or ordinance (Constitution, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the  
8 "O'odham Voice on Use of Gaming Revenues" (the "Initiative"), which authorizes  
9 per capita payments to the Nation's members provided that sufficient gaming  
10 revenues are available; and

11 **WHEREAS,** the Ordinance for the Regulation of Gaming Activities Within the Tohono  
12 O'odham Nation ("Gaming Ordinance") was subsequently amended to authorize  
13 per capita distribution payments in accordance with the Initiative (Legislative  
14 Council Resolution No. 97-303); and

15 **WHEREAS,** the Trust Agreement with Principal Trust Company requires that a listing of all  
16 minor beneficiaries turning 18 that month be presented to the Tohono O'odham  
17 Legislative Council to obtain approval to distribute the trust funds to these  
18 eligible minor members as they are no longer restricted beneficiaries; and

19 **WHEREAS,** by Resolution Nos. 12-346 and 14-004, the Tohono O'odham Legislative Council  
20 approved the Monthly Age 18 Reports for September 2012 and January 2014 of  
21 eligible minor members who reached the age of 18 and are no longer restricted  
22 from receiving their per capita payments; and

23 **WHEREAS,** the Nation's Enrollment Office has identified incorrect names and/or roll  
24 numbers for members on the Monthly Age 18 Reports for September 2012 and  
25 January 2014 and recommends that the members' names and/or roll numbers be  
26 corrected in accordance with the Monthly Age 18 Report Amendment Summary  
27 June 2023, which is incorporated by this reference; and

28 **WHEREAS,** the Rules Committee has reviewed the Enrollment Office's recommendation and  
29 recommends approval.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves amending the Monthly Age 18 Report for September 2012, approved by Resolution No. 12-346, and the Monthly Age 18 Report for January 2014, approved by Resolution No. 14-004, to correct names and/or roll numbers of members in accordance with the Monthly Age 18 Report Amendment Summary June 2023.

BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes Principal Trust Company to commence payment to the non-restricted beneficiaries listed on the Monthly Age 18 Report Amendment Summary June 2023, subject to the additional requirements of the Trust Agreement and written confirmation of the beneficiary's current mailing address and other information.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup> day of JUNE, 2023 at a meeting at which a quorum was present with a vote of 3,001.4 FOR; -0- AGAINST; -0- NOT VOTING; and 216.6 [05] ABSENT, pursuant to the powers vested in the Council by, Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).


