

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Department of Public Safety Environmental Protection
Office ("EPO") General Assistance Program ("GAP") Budget Amendment No. 1)**

RESOLUTION NO. 23-212

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation ... and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2023 Department of Public Safety Environmental Protection Office ("EPO")**
8 **General Assistance Program ("GAP") Budget in the amount of \$689,666.19 was**
9 **approved by Resolution No. 22-286 ; and**

10 **WHEREAS, the Department of Public Safety has prepared and submitted for review and**
11 **approval its FY 2023 EPO GAP Budget Amendment No. 1, which is incorporated by**
12 **this reference and which will adjust operational and/or personnel line items;**
13 **and**

14 **WHEREAS, the FY 2023 Department of Public Safety EPO GAP Budget Amendment No. 1 will**
15 **increase the FY 2023 Department of Public Safety EPO GAP Budget by \$333,924.72**
16 **from \$689,666.19 to \$1,023,590.91; and**

17 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the FY**
18 **2023 Department of Public Safety EPO GAP Budget Amendment No. 1 and**
19 **recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2023 Department of Public Safety EPO GAP Budget Amendment No. 1, which**
22 **includes a \$333,924.72 increase from \$689,666.19 to \$1,023,590.91.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
24 **Nation chairperson or any designated official is authorized to administer and**
25 **expend the FY 2023 Department of Public Safety EPO GAP Budget as amended,**
26 **provided that any amendments or modifications shall be submitted for prior**
27 **approval by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH**
29 **day of JUNE, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**
30 **-0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by,**
31 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
34 **18, 1934 (48 Stat.984).**


