

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2023 Department of Health and Human Services Division of Child  
Welfare Services Title IV-B Subparts One and Two Carry Over Budgets)**

**RESOLUTION NO. 23-217**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets  
5 authorized under resolutions or in accordance with ordinances" of the Tohono  
6 O'odham Legislative Council, and "to . . . approve . . . annual budgets and to  
7 authorize the expenditure of funds in accordance with these budgets  
8 (Constitution of the Tohono O'odham Nation, Article VI, Section 1(d)(2) and (3));  
9 and

10 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for  
11 review and approval its FY 2023 Division of Child Welfare Services Title IV-B  
12 Subpart One Carry Over Budget, which is incorporated by this reference, in the  
13 amount of \$80,463.78, which shall be funded by the Nation's general fund pending  
14 reimbursement from the grantor, the Stephanie Tubbs Jones Child Welfare  
15 Services Program, and the FY 2023 Division of Child Welfare Services Title IV-B  
16 Subpart Two Carry Over Budget, which is incorporated by this reference, in the  
17 amount of \$18,700.41, which shall be funded by the Nation's general fund pending  
18 reimbursement from the grantor, the Promoting Safe and Stable Families  
19 Program; and

20 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have  
21 reviewed the FY 2023 Department of Health and Human Services Division of Child  
22 Welfare Services Title IV-B Subparts One and Two Carry Over Budgets and  
23 recommend their approval.

24 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
25 FY 2023 Department of Health and Human Services Division of Child Welfare  
26 Services Title IV-B Subpart One Carry Over Budget effective October 1, 2022  
27 through September 30, 2023 in the amount of \$80,463.78 which shall be funded by  
28 the Nation's general fund pending reimbursement from the grantor, the  
29 Stephanie Tubbs Jones Child Welfare Services Program, and the FY 2023  
30 Department of Health and Human Services Division of Child Welfare Services  
31 Title IV-B Subpart Two Carry Over Budget effective October 1, 2022 through  
32 September 30, 2023 in the amount of \$18,700.41, which shall be funded by the

Nation's general fund pending reimbursement from the grantor, the Promoting Safe and Stable Families Program.

**BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham Nation chairperson or any designated official is authorized to administer and expend the FY 2023 Department of Health and Human Services Division of Child Welfare Services Title VI-B Subparts One and Two Carry Over Budgets, provided that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup> day of JUNE, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
