

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2023 Department of Health and Human Services, Division of Senior Services BIA Adult Care Program Budget Amendment No. 1)

RESOLUTION NO. 23-227

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d) (2)); and

7 **WHEREAS,** the Tohono O'odham Legislative Council approved the FY 2023 Department of
8 Health and Human Services, Division of Senior Services BIA Adult Care Program
9 Budget by Resolution No. 22-266 on August 8, 2022, in the amount of \$203,433.00;
10 and

11 **WHEREAS,** the Department of Health and Human Services, Division of Senior Services
12 prepared and submitted for review and approval its FY 2023 BIA Adult Care
13 Program Budget Amendment No. 1, which is incorporated by this reference, and
14 which will create new line items and adjust operational line items that will
15 increase the budget by \$53,882.00 from \$203,433.00 to \$257,315.00; and

16 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
17 reviewed the FY 2023 Department of Health and Human Services, Division of
18 Senior Services BIA Adult Care Program Budget Amendment No. 1 and
19 recommend its approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
21 FY 2023 Department of Health and Human Services, Division of Senior Services
22 BIA Adult Care Program Budget Amendment No.1 effective October 1, 2022, in the
23 amount of \$257,315.00 that shall be funded by the Bureau of Indian Affairs.

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
25 Nation chairperson or any designated official is authorized to administer and
26 expend the FY 2023 Department of Health and Human Services, Division of Senior
27 Services BIA Adult Care Program Budget Amendment No. 1, provided that any
28 amendments or modifications shall be submitted for prior approval by the
29 Tohono O'odham Legislative Council.
