11		prepared and submitted for review and approval its FY 2023 BIA Social Services
12		Program Budget Amendment No. 1, which is incorporated by this reference, and
13		which will create new line items and adjust operational line item, and will
14		increase the budget by \$259,162.55 from \$949,908.00 to \$1,209,070.55; and
15	WHEREAS,	the Health and Human Services and Budget and Finance Committees have
16		reviewed the FY 2023 Department of Health and Human Services, Division of
17		Family Assistance BIA Social Services Program Budget Amendment No. 1 and
18		recommend its approval.

20		FY 2023 Department of Health and Human Services, Division of Family Assistance

23		pending reimbursement from the grantor, the Bureau of Indian Affairs.
