

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Department of Health and Human Services Division of
Family Assistance USDA Food Distribution Budget Amendment No. 2)

RESOLUTION NO. 23-229

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d) (2)); and

7 **WHEREAS,** the FY 2023 Department of Health and Human Services, Division of Family
8 Assistance USDA Food Distribution Budget in the amount of \$284,836.12 was
9 approved by Resolution No. 22-292 and amended to \$361,336.00 which was
10 approved by Resolution No. 23-083; and

11 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
12 review and approval its FY 2023 USDA Food Distribution Budget Amendment No.
13 2, which is incorporated by this reference, and which will increase the budget by
14 \$30,940.76 from \$361,336.00 to \$392,276.76, to be funded by the Nation's General
15 Fund pending reimbursement from the United States Department of Agriculture;
16 and

17 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
18 reviewed the FY 2023 Department of Health and Human Services Division of
19 Family Assistance USDA Food Distribution Budget Amendment No. 2 and
20 recommend its approval.

21 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
22 FY 2023 Department of Health and Human Services Division of Family Assistance
23 USDA Food Distribution Budget Amendment No. 2 effective October 1, 2022 which
24 will increase the budget by \$30,940.76 from \$361,336.00 to \$392,276.76 which shall
25 be funded by the Nation's General Fund pending reimbursement from the United
26 States Department of Agriculture.

27 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
28 Nation chairperson or any designated official is authorized to administer and
29 expend the FY 2023 Department of Health and Human Services Division of Family
30 Assistance USDA Food Distribution Budget Amendment No. 2, provided that any
31 amendments or modifications shall be submitted for prior approval by the
32 Tohono O'odham Legislative Council.


