

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 San Xavier District Budget Amendment No. 1)**

RESOLUTION NO. 23-232

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only by**
6 **a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

11 **; and**

12 **WHEREAS,** the FY 2023 San Xavier District Budget in the amount of \$9,257,138.84 was
13 authorized by San Xavier District Council Resolution No. SXDC 08-22-17 and
14 approved by Legislative Council Resolution No. 22-333; and

15 **WHEREAS,** by San Xavier District Council Resolution No. SXDC 06-23-03, the San Xavier
16 District has authorized and submitted for review and approval its FY 2023 San
17 Xavier District Budget Amendment No. 1, which is incorporated by this reference
18 and which will adjust operational and/or personnel line items; and

19 **WHEREAS,** the FY 2023 San Xavier District Budget Amendment No. 1 will increase the FY 2023
20 San Xavier District Budget by \$900,000.00 from \$9,257,138.84 to \$10,157,138.84;
21 and

22 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2023 San Xavier District
23 Budget Amendment No. 1 and recommends its approval.

24 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
25 **FY 2023 San Xavier District Budget Amendment No. 1 effective October 1, 2022,**
26 **which includes a \$900,000.00 increase from \$9,257,138.84 to \$10,157,138.84 that**
27 **shall be funded by the San Xavier District's Operating Account.**

28 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2023 San
29 **Xavier District Budget as amended shall be managed and expended in**
30 **accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham**
31 **Nation and the Nation's laws, provided that any amendments or modifications**
32 **shall be authorized under District Council resolution and submitted for prior**
33 **approval by the Tohono O'odham Legislative Council.**


The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH day of JUNE, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Authority: Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).


