

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Executive Branch Traditional O'odham Leaders
Budget Amendment No. 1)**

RESOLUTION NO. 23-233

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2023 Executive Branch Traditional O'odham Leaders Budget in the amount
8 of \$180,435.80 was approved by Resolution No. 22-295; and

9 **WHEREAS,** the Executive Branch has prepared and submitted for review and approval its FY
10 2023 Traditional O'odham Leaders Budget Amendment No. 1, which is
11 incorporated by this reference and which will adjust operational and/or
12 personnel line items; and

13 **WHEREAS,** the FY 2023 Executive Branch Traditional O'odham Leaders Budget Amendment
14 No. 1 will not change the overall amount of the original budget; and

15 **WHEREAS,** the Domestic Affairs and Budget and Finance Committees have reviewed the FY
16 2023 Executive Branch Traditional O'odham Leaders Budget Amendment No. 1
17 and recommend its approval.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
19 FY 2023 Executive Branch Traditional O'odham Leaders Amendment No. 1
20 effective October 1, 2022, which will adjust operational and personnel line items,
21 and which will not change the amount of the original budget, and which shall be
22 funded by the Nation's general fund.

23 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
24 Nation chairperson or any designated official is authorized to administer and
25 expend the FY 2023 Executive Branch Traditional O'odham Leaders Budget as
26 amended, provided that any amendments or modifications shall be submitted
27 for prior approval by the Tohono O'odham Legislative Council.

28 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST
29 day of JUNE, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;
30 -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by,
31 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by
32 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
33 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
34 18, 1934 (48 Stat.984).
