

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Department of Education One Stop Public Law 102-477
Budget Amendment No. 1)

RESOLUTION NO. 23-236

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2023 Department of Education One Stop Public Law 102-477 Budget in the
8 amount of \$1,141,042.67 was approved by Resolution No. 22-320; and

9 **WHEREAS,** the Department of Education has prepared and submitted for review and
10 approval its FY 2023 One Stop Public Law 102-477 Budget Amendment No. 1, which
11 is incorporated by this reference, which will adjust operational and personnel
12 line items and create line items; and

13 **WHEREAS,** the FY 2023 Department of Education One Stop Public Law 102-477 Budget
14 Amendment No. 1 will not increase the FY 2023 One Stop Public Law 102-477
15 Budget amount of \$1,141,042.67; and

16 **WHEREAS,** the Human Resources Development and Budget and Finance Committees have
17 reviewed the FY 2023 Department of Education One Stop Public Law 102-477
18 Budget Amendment No. 1 and recommend its approval.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
20 FY 2023 Department of Education One Stop Public Law 102-477 Budget
21 Amendment No. 1 effective October 1, 2022, which will not increase the budget
22 amount of \$1,141,042.67, which shall be funded by the Bureau of Indian Affairs
23 102-477 funding.

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
25 Nation chairperson or any designated official is authorized to administer and
26 expend the FY 2023 Department of Education One Stop Public Law 102-477 Budget
27 as amended, provided that any amendments or modifications shall be submitted
28 for prior approval by the Tohono O'odham Legislative Council.
