**RESOLUTION NO. 23-239**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**  
2 **and ordinances governing the enrollment and adoption of members**  
3 **(Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and**  
4 **Article VI, Section 1(h)); and**

5 **WHEREAS, pursuant to Article VI and VII of the Nation's Enrollment Ordinance, the**  
6 **Enrollment Committee shall review membership applications and make a**  
7 **written recommendation to the Tohono O'odham Legislative Council to approve**  
8 **or reject the application (14 Tohono O'odham Code Chapter 1 - Enrollment**  
9 **Ordinance); and**

10 **WHEREAS, pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono**  
11 **O'odham Legislative Council shall determine eligibility for membership or**  
12 **adoption; and**

13 **WHEREAS, the Enrollment Program has received official documents reflecting the legal**  
14 **name changes of enrolled members as a result of marriage, divorce, legal**  
15 **adoption, or for other reasons; and**

16 **WHEREAS, the Enrollment Committee recommends that Resolution Nos. 15-82, 127-83,**  
17 **184-84, 334-88, 91-161, 91-342, 95-484, 96-129, 96-547, 99-039, 99-633, 2000-147, 05-**  
18 **204, 07-075, 13-001, 19-223, 19-386, and 22-157 be amended to reflect the legal**  
19 **name changes of members identified in the July 2023 Legal Enrollment**  
20 **Resolution Summary, which is incorporated by this reference.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**  
22 **Nos. 15-82, 127-83, 184-84, 334-88, 91-161, 91-342, 95-484, 96-129, 96-547, 99-039,**  
23 **99-633, 2000-147, 05-204, 07-075, 13-001, 19-223, 19-386, and 22-157 are amended**  
24 **upon the effective date of those resolutions to reflect the legal name changes of**  
25 **members identified in the July 2023 Legal Enrollment Resolution Summary.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup>**  
27 **day of JULY, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**  
28 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by,**  
29 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham**  
30 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**  
31 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**  
32 **16 of the Act of June 18, 1934 (48 Stat.984).**


