

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Enrollment Resolution Nos. 132-83, 164-83, 10-337, 10-462, 11-158,  
06-059, 06-222, and 09-229 to Correct Names of Enrolled Members)**

**RESOLUTION NO. 23-240**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**  
2 **and ordinances governing the enrollment and adoption of members**  
3 **(Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and**  
4 **Article VI, Section 1(h)); and**

5 **WHEREAS, pursuant to Article VI and VII of the Nation's Enrollment Ordinance, the**  
6 **Enrollment Committee shall review membership applications and make a**  
7 **written recommendation to the Tohono O'odham Legislative Council to approve**  
8 **or reject the application (14 Tohono O'odham Code Chapter 1 - Enrollment**  
9 **Ordinance); and**

10 **WHEREAS, pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono**  
11 **O'odham Legislative Council shall determine eligibility for membership or**  
12 **adoption; and**

13 **WHEREAS, the Enrollment Program has determined that a number of resolutions approving**  
14 **membership and adoption applications misspelled or incorrectly listed the**  
15 **names of members; and**

16 **WHEREAS, the Enrollment Committee recommends that Resolution Nos. 132-83, 164-83,**  
17 **10-337, 10-462, 11-158, 06-059, 06-222, and 09-229 be amended to reflect the**  
18 **correct names of members identified in the July 2023 Corrected Enrollment**  
19 **Resolution Summary, which is incorporated by this reference.**

20 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**  
21 **Nos. 132-83, 164-83, 10-337, 10-462, 11-158, 06-059, 06-222, and 09-229 are**  
22 **amended upon the effective date of those resolutions to reflect the correct names**  
23 **of members identified in the July 2023 Corrected Enrollment Resolution**  
24 **Summary.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup>**  
26 **day of JULY, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**  
27 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by,**  
28 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham**  
29 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**  
30 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**  
31 **16 of the Act of June 18, 1934 (48 Stat.984).**


