12	WHEREAS,	the Gu Achi District Budget in the amount of \$3,932,391.66 was authorized by Gu
13		Achi District Council Resolution No. 0622-113 and approved by Legislative
14	*	Council Resolution No. 22-347; and
15	WHEREAS,	by Gu Achi District Council Resolution No. 0623-196, the Gu Achi District has
16		authorized and submitted for review and approval its FY 2023 Gu Achi District
17		Budget Amendment No. 1, which is incorporated by this reference and which will
18		adjust operational and/or personnel line items; and
19	WHEREAS,	the FY 2023 Gu Achi District Budget Amendment No. 1 will not change the FY 2023
20		Gu Achi District Budget amount of \$3,932,391.66; and
21	WHEREAS,	the Budget and Finance Committee has reviewed the FY 2023 Gu Achi District
22		Budget Amendment No. 1 and recommends its approval.
23	NOW, THERI	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
24		FY 2023 Gu Achi District Budget Amendment No. 1, effective October 1, 2022, which
25		will not change the FY 2023 Gu Achi District Budget amount of \$3,932,391.66.
26	BE IT FINALI	LY RESOLVED by the Tohono O'odham Legislative Council that the FY 2023 Gu Achi
27		District Budget as amended shall be managed and expended in accordance with
28		Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the
29		Nation's laws, provided that any amendments or modifications shall be
30		authorized under District Council resolution and submitted for prior approval by
31		the Tohono O'odham Legislative Council.
