## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Removal of Allison Ramirez from the Institutional Review Board)

**RESOLUTION NO. 23-254** 

1	WHEREAS,	the Constitution of the Tohono O'odham Nation vests the Legislative Council with
2		the authority to "promote, protect and provide for public health, peace, morals,
3		education and general welfare of the Tohono O'odham Nation and its
4		members" and to "provide for, appoint, or provide for the appointment of, and
5		prescribe the duties and powers of committees, boards, officers and agents"
6		(Constitution, Article VI, Section 1(c)(2) and Section 1(b)); and
7	WHEREAS,	the Nation's "Research Code" was enacted and codified as 17 Tohono O'odham
8		Code Chapter 8 by Resolution No. 13-165, effective May 23, 2013; and
9	WHEREAS,	Section 8104 (A) of the Research Code establishes an Institutional Review Board
10	•	("IRB") to administer the Code and to approve and disapprove research proposals
11		submitted in accordance with the law (17 T.O.C Chapter 8, Section 8104 (A)); and
12	WHEREAS,	IRB members are nominated by the chairperson of the Nation and appointed by
13	-	the Legislative Council (17 T.O.C Chapter 8, Section 8104(C)); and
14	WHEREAS,	pursuant to Section 8104 (F) of the Research Code, "[a]n IRB member may be
15		removed with or without cause by the Nation's chairperson with the concurrence
16		by majority vote of the Legislative Council." (17 Tohono O'odham Code Chapter 8);
17		and
18	WHEREAS,	by Resolution No. 21-142, the Legislative Council appointed Allison Ramirez to the
19		Institutional Review Board for a three-year term expiring on September 30, 2024;
20		and
21	WHEREAS,	the Chairman of the Nation and the Human Resources Development Committee
22		recommend the removal of Allison Ramirez from the Institutional Review Board.
23	NOW, THER	EFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Allison
24		Ramirez is removed from the Institutional Review Board effective on the date this
25		resolution is executed.
