

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2023 Veterans Affairs Office Donations and Contributions  
Budget Amendment No. 1)**

**RESOLUTION NO. 23-261**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2023 Veterans Affairs Office Donations and Contributions Budget in the**  
8 **amount of \$42,013.60 was approved by Resolution No. 23-047; and**

9 **WHEREAS, the Veteran's Affairs Office has prepared and submitted for review and approval**  
10 **its FY 2023 Veteran's Affairs Donations and Contribution Budget Amendment No.**  
11 **1, which is incorporated by this reference and which will adjust operational line**  
12 **items; and**

13 **WHEREAS, the FY 2023 Veterans Affairs Office Donations and Contributions Budget**  
14 **Amendment No. 1 will increase the budget by \$800.00 from \$42,013.60 to**  
15 **\$42,813.60; and**

16 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**  
17 **reviewed the FY 2023 Veterans Affairs Office Donations and Contributions Budget**  
18 **Amendment No. 1 and recommend approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
20 **FY 2023 Veterans Affairs Office Donations and Contributions Budget effective**  
21 **October 1, 2022 which includes an \$800.00 increase from \$42,013.60 to \$42,813.60,**  
22 **which is a donation received from the Desert Diamond Casinos which in part is**  
23 **placed in the Veteran's Affairs Donations and Contributions Funds.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
25 **Nation chairperson or any designated official is authorized to administer and**  
26 **expend the FY 2023 Veterans Affairs Office Donations and Contributions Budget**  
27 **as amended, provided that any amendments or modifications shall be submitted**  
28 **for prior approval by the Tohono O'odham Legislative Council.**
