9	WHEREAS,	the Department of Natural Resources Veterinary Program has prepared and
10		submitted for review and approval its FY 2023 Budget Amendment No. 1, which is
11		incorporated by this reference and which will adjust operational line and capital
12		line items; and
13	WHEREAS,	the Agriculture and Natural Resources and the Budget and Finance Committees
14		of the Tohono O'odham Legislative Council have reviewed the FY 2023
15		Department of Natural Resources Veterinary Program Budget Amendment No. 1
16		and recommend its approval.
17	NOW, THERI	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
18		FY 2023 Department of Natural Resources Veterinary Program Budget
19		Amendment No. 1 with no change to the overall budgeted amount.

24		submitted for further prior approval by the Tohono O'odham Legislative Council.
