

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 - FY 2026 Department of Natural Resources Livestock
Facilities Improvement Budget)**

RESOLUTION NO. 23-264

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1 (d) (2); and

7 **WHEREAS,** the Tohono O'odham Nation has awarded funding for the project period of four
8 years beginning October 1, 2022 and ending September 30, 2026 and the
9 Department of Natural Resources has prepared budget(s) to expend funds for the
10 budget period to provide continued service; and

11 **WHEREAS,** the Department of Natural Resources has prepared and submitted for review and
12 approval its FY 2023 - FY 2026 Livestock Facilities Improvement Budget, which is
13 incorporated by this reference, in the amount of \$1,083,000.00 to be funded from
14 the Nations general fund; and

15 **WHEREAS,** the Agriculture and Natural Resource and Budget and Finance Committees have
16 reviewed the FY 2023 - FY 2026 Department of Natural Resources Livestock
17 Facilities Improvement Budget and recommend its approval; and

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
19 **FY 2023 - FY 2026 Department of Natural Resources Livestock Facilities**
20 **Improvement Budget effective October 1, 2022 ending September 30, 2026 in**
21 **amount of \$1,083,000.00 which shall be funded by the Nation's general fund; and**

22 **BE IT FURTHER RESOLVED** that the Department of Natural Resources is authorized to utilize
23 **funding for the period beginning October 1, 2022, and ending September 30, 2026.**

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
25 **Nation chairperson or any designated official is authorized to administer and**
26 **expend these funds for the period of October 1, 2022 to September 30, 2026, and**
27 **the Accounting Department is authorized to post the unexpended balance of the**
28 **budget, provided that any amendments or modifications shall be submitted for**
29 **prior approval by the Tohono O'odham Legislative Council.**
