

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Memorandum of Understanding Between the Tohono O'odham Nation,
Department of Health and Human Service and Spectrum Healthcare Group, Inc.)

RESOLUTION NO. 23-265

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to "consult,
2 negotiate and conclude agreements . . . on behalf of the Tohono O'odham Nation
3 with Federal, State and local governments . . . or their departments, agencies, or
4 political subdivisions . . . on all matters within the authority of the Tohono
5 O'odham Council" and to "promote, protect and provide for public health, peace,
6 morals, education and general welfare of the Tohono O'odham Nation and its
7 members" (Constitution of the Tohono O'odham Nation, Article VI, Section 1(f)
8 and Article VI, Section 1(c)(2); and

9 **WHEREAS,** the Tohono O'odham Nation Department of Health and Human Services desires
10 the Tohono O'odham Nation execute the Memorandum of Understanding
11 Between the Tohono O'odham Nation, Department of Health and Human Services
12 and Spectrum Healthcare Group, Inc., which has been provided to the Legislative
13 Council and is attached to this Resolution; and

14 **WHEREAS,** Spectrum Healthcare Group, Inc. shall provide access or coordinate access to
15 certain behavioral health services to the Nation's Members; and

16 **WHEREAS,** the Health and Human Services Committee has reviewed the Memorandum of
17 Understanding Between the Tohono O'odham Nation, Department of Health and
18 Human Services and Spectrum Healthcare Group, Inc. and recommends its
19 approval; and

20 **WHEREAS,** the Memorandum of Understanding Between the Tohono O'odham Nation,
21 Department of Health and Human Services and Spectrum Healthcare Group, Inc
22 will be effective beginning on July 1, 2023.

23 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
24 Memorandum of Understanding Between the Tohono O'odham Nation,
25 Department of Health and Human Services and Spectrum Healthcare Group, Inc.

26 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
27 Nation chairperson or any designated official is authorized to execute the
28 Memorandum of Understanding Between the Tohono O'odham Nation,
29 Department of Health and Human Services and Spectrum Healthcare Group, Inc.
30 substantially in the form attached hereto provided that any amendments shall be
31 submitted for prior approval by the Tohono O'odham Legislative Council.
