

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Department of Health and Human Services Division of Behavioral Health Tribal Opioid Response Program Budget Amendment No. 1)

RESOLUTION NO. 23-266

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Tohono O'odham Legislative Council approved the FY 2023 Department of
8 Health and Human Services Behavioral Health Tribal Opioid Response Program
9 Budget in the amount of \$700,000.00 by Resolution No. 22-350; and

10 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
11 review and approval its FY 2023 Behavioral Health Tribal Opioid Response
12 Program Budget Amendment No.1, which is incorporated by this reference, and
13 which will adjust operational line items and increase indirect costs; and

14 **WHEREAS,** the FY 2023 Department of Health and Human Services Behavioral Health Tribal
15 Opioid Response Program Budget Amendment No. 1 will increase by \$951,078.94
16 from \$700,000.00 to \$1,651,078.94; and

17 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
18 reviewed the FY 2023 Department of Health and Human Services Behavioral
19 Health Tribal Opioid Response Program Budget Amendment No. 1 and
20 recommend its approval.

21 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
22 FY 2023 Department of Health and Human Services Behavioral Health Behavioral
23 Health Tribal Opioid Response Program Budget Amendment No. 1 effective
24 September 30, 2022 in the amount \$1,651,078.94, which shall be funded by the
25 Nation's general fund pending reimbursement from the grantor U.S. Department
26 of Health and Human Services, Substance Abuse and Mental Health Services
27 Administration.

28 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
29 Nation chairperson or any designated official is authorized to administer and
30 expend the FY 2023 Department of Health and Human Services Behavioral Health
31 Tribal Opioid Response Program Budget Amendment No. 1, provided that any




