

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Department of Health and Human Services Healthy O'odham
Promotion Program Budget Amendment No. 1)**

RESOLUTION NO. 23-267

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d) (2)); and

7 **WHEREAS,** the FY 2024 Department of Health and Human Services Healthy O'odham
8 Promotion Program Budget in the amount of \$2,241,130.00 was approved by
9 Resolution No. 23-013; and

10 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
11 review and approval its FY 2024 Healthy O'odham Promotion Program Budget
12 Amendment No. 1, which is incorporated by this reference and which will adjust
13 personnel and operational line items and decrease indirect costs; and

14 **WHEREAS,** the FY 2024 Department of Health and Human Services Healthy O'odham
15 Promotion Program Amendment No. 1 will not affect the original budget amount
16 of \$2,241,130.00; and

17 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
18 reviewed the FY 2024 Department of Health and Human Services Healthy
19 O'odham Promotion Program Budget Amendment No. 1 and recommend its
20 approval.

21 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
22 **FY 2024 Department of Health and Human Services Healthy O'odham Promotion**
23 **Program Budget Amendment No. 1 effective January 1, 2023, that shall be funded**
24 **by the Nation's general fund pending reimbursement from the grantor, the**
25 **Indian Health Service Special Diabetes Program for Indians.**

26 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
27 **Nation chairperson or any designated official is authorized to administer and**
28 **expend the FY 2024 Department of Health and Human Services Healthy O'odham**
29 **Promotion Program Budget as amended, provided that any further amendments**
30 **or modifications shall be submitted for prior approval by the Tohono O'odham**
31 **Legislative Council.**


