

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Department of Health and Human Services Division of Senior
Services Title VI Amendments No. 1)

RESOLUTION NO. 23-269

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2024 Department of Health and Human Services Division of Senior Services
8 Title VI Budgets totaling the amount of \$276,461.00 were approved by Resolution
9 No. 23-111; and

10 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
11 review and approval its FY 2024 Title VI Part A, Title VI Part C and Title VI NSIP
12 Amendments No. 1, which is incorporated by this reference, and which will adjust
13 and create new operational line item and increase indirect costs; and

14 **WHEREAS,** the FY 2024 Department of Health and Human Services Title VI Budget
15 Amendments No. 1 will increase the original budgets from \$276,461.00 to
16 \$280,912.00, a total combined increase by \$4,451.00; and

17 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
18 reviewed the FY 2024 Department of Health and Human Services Division of
19 Senior Services Title VI Amendments No. 1 and recommend their approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
21 FY 2024 Department of Health and Human Services Division of Senior Services
22 Title VI Budget Amendments No.1 effective April 1, 2023. As follows:

- 23 1. Title VI Part C Caregivers Budget will increase by \$640.00 from
24 \$74,360.00 to \$75,000.00.
- 25 2. Title VI Part A Elders Program Budget will increase by \$3,820.00 from
26 \$192,710.00 to \$196,530.00.
- 27 3. Title VI NSIP Budget will decrease by \$9.00 from \$9,391.00 to \$9,382.00.

28 for a combined total increase of \$4,451.00 from \$276,461.00 to \$280,912.00 and
29 which shall be funded by the Nation's general fund pending reimbursement from
30 the grantor, the Administration for Community Living, pursuant to Title VI of the
31 Older Americans Act of 1978.

1 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
2 Nation chairperson or any designated official is authorized to administer and
3 expend the FY 2024 Department of Health and Human Services Division of Senior
4 Services Title VI Budgets as amended, provided that any amendments or
5 modifications shall be submitted for prior approval by the Tohono O'odham
6 Legislative Council.

7 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH
8 day of JULY, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;
9 ~~-0-~~ AGAINST; ~~-0-~~ NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by,
10 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by
11 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
12 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
13 18, 1934 (48 Stat.984).
