

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending Enrollment Resolution No. 19-134 to Correct the Name of One Enrolled Member)**

**RESOLUTION NO. 23-286**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**  
2 **and ordinances governing the enrollment and adoption of members (Article II,**  
3 **Sections 1 and 2 and Article VI, Section 1(b) of the Constitution of the Tohono**  
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**  
6 **Enrollment Committee is responsible for reviewing enrollment applications and**  
7 **making recommendations to the Legislative Council regarding the eligibility of**  
8 **applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and**

9 **WHEREAS, Article VIII of the Nation's Enrollment Ordinance, the Tohono O'odham**  
10 **Legislative Council shall determine eligibility for membership or adoption; and**

11 **WHEREAS, by Resolution No. 19-134, the Tohono O'odham Legislative Council approved the**  
12 **Monthly Age 18 Report for May 2019 of eligible minor members who reached the**  
13 **age of 18 and are no longer restricted from receiving their per capita payments;**  
14 **and**

15 **WHEREAS, the Enrollment Program has determined that a number of resolutions approving**  
16 **membership and adoption applications misspelled or incorrectly listed the**  
17 **names of members; and**

18 **WHEREAS, the Enrollment Committee recommends that Resolution No. 19-134 be amended**  
19 **to reflect the correct name for the member identified in the Monthly Age 18**  
20 **Report Amendment Summary August 2023, which is incorporated by this**  
21 **reference; and**

22 **WHEREAS, the Rules Committee has reviewed the Enrollment Committee's**  
23 **recommendations and recommends approval.**

24 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**  
25 **No. 19-134 is amended upon the effective date of the resolution to reflect the**  
26 **correct name for the member identified in the Monthly Age 18 Report**  
27 **Amendment Summary August 2023.**

28 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes Principal**  
29 **Trust Company to commence payment to the non-restricted beneficiary listed on**  
30 **the Monthly Age 18 Report Amendment Summary August 2023, subject to the**  
31 **additional requirements of the Trust Agreement and written confirmation of the**  
32 **beneficiary's current mailing address and other information.**




1 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup>
