

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving an Addition to the Master List for Eligible Minor Tohono O'odham  
Members for the Third Per Capita Distribution and Authorizing the Transfer  
of Funds to set up a Trust Account at Principal Trust Company)**

**RESOLUTION NO. 23-289**

1 **WHEREAS, on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, "O'odham**  
2 **Voice on Use of Gaming Revenues" ("Initiative"), which authorizes per capita**  
3 **payments to the Nation's members provided that sufficient gaming revenues are**  
4 **available; and**

5 **WHEREAS, the Ordinance for the Regulation of Gaming Activities Within the Tohono**  
6 **O'odham Nation ("Gaming Ordinance") was subsequently amended to authorize**  
7 **per capita distribution payments in accordance with the Initiative (Legislative**  
8 **Council Resolution No. 97-303); and**

9 **WHEREAS, the Legislative Council did adopt the Tohono O'odham Nation Revenue Allocation**  
10 **Plan pursuant to Legislative Council Resolution No. 06-307; and**

11 **WHEREAS, on July 28, 2006, the Tohono O'odham Nation received notice from the Secretary**  
12 **of the Department of Interior that the Tohono O'odham Nation Revenue**  
13 **Allocation Plan was approved; and**

14 **WHEREAS, the Tohono O'odham Nation Department of Membership Services submitted to**  
15 **the Tohono O'odham Legislative Council the Master List for Eligible Minor**  
16 **Tohono O'odham Members for the Third Per Capita Distribution ("Master List")**  
17 **for review and approval; and**

18 **WHEREAS, Legislative Council approved the Master List with the initial number of 9,282**  
19 **verified minor members (Resolution Number 09-429); and**

20 **WHEREAS, the Enrollment Program has identified one eligible minor member who was left**  
21 **off the Master List for the third per capita distribution; and**

22 **WHEREAS, the one minor member eligible for the third per capita payment did not have the**  
23 **Principal Trust Company account established in accordance with the Principal**  
24 **Trust Agreement, which was approved by Tohono O'odham Legislative Council**  
25 **Resolution No. 06-258; and**

26 **WHEREAS, the Nation's Treasurer has calculated the accrued interest due to the eligible**  
27 **minor member for the third per capita payment.**

28 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 29 **1. Approves the addition of one eligible Tohono O'odham minor member to the**  
30 **Master List for Eligible Minor Tohono O'odham Members for the Third Per**

- 3                                    2. **Authorizes the Office of the Treasurer to transfer \$2,000.00 from the**  
4                                    **Principal Trust Company Third Per Capita Excess Funds Account to establish**  
5                                    **a trust account for the minor at Principal Trust Company pursuant to the**  
6                                    **terms of the Trust Agreement approved by Tohono O'odham Legislative**  
7                                    **Council Resolution No. 06-258.**  
8                                    3. **Authorizes the Office of the Treasurer to transfer \$1,628.91 from the**  
9                                    **Principal Trust Company Third Per Capita Excess Funds Account to pay the**  
10                                   **accrued interest income due for the third per capita payment.**  
11                                   4. **Authorizes the Chairperson of the Nation or a designated official to execute**  
12                                   **such other documents as may be necessary to implement this resolution.**

13 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that any future additions**  
14 **to the Master List for Minor Eligible Members for the Third Per Capita**  
15 **Distribution is subject to the approval of the Tohono O'odham Legislative**  
16 **Council.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup>**  
18 **day of AUGUST 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**  
19 **-0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by,**  
20 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
21 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
22 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
23 **18, 1934 (48 Stat.984).**
