

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Attorney Contracts for the Office of Attorney General)**

RESOLUTION NO. 23-297

1 **WHEREAS, the Tohono O'odham Legislative Council vests the Legislative Council with the**
2 **power to "employ legal counsel for the protection and advancement of the rights**
3 **of the Tohono O'odham Nation" (Constitution of the Tohono O'odham Nation,**
4 **Article VI, Section 2(a)); and**

5 **WHEREAS, the Office of Attorney General has prepared and submitted for review and**
6 **approval its FY 2024 Attorney Contracts ("Attorney Contracts") with thirteen**
7 **firms, for the purposes and for the amounts indicated in attached Exhibit A; and**

8 **WHEREAS, fees for services for these thirteen Attorney Contracts will be paid by the FY 2024**
9 **Office of Attorney General Budget; and**


10 **WHEREAS, The Domestic Affairs Committee has reviewed the thirteen FY 2024 Attorney**
11 **Contracts and recommends approval.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:**

- 13 **1. Approves the thirteen Attorney Contracts for FY 2024 for the Office of**
14 **Attorney General, which shall be funded from the Office of the Attorney**
15 **General Budget and shall be effective from October 1, 2023 to September**
16 **30, 2024.**
- 17 **2. Authorizes the Tohono O'odham Nation Chairperson to execute the**
18 **thirteen Attorney Contracts in substantially the form attached.**
- 19 **3. Authorizes the Chairman of the Nation or any designated official to**
20 **administer the thirteen Attorney Contracts, provided that any**
21 **amendments or modifications shall be submitted for prior approval by**
22 **the Tohono O'odham Nation Legislative Council**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**
24 **day of AUGUST 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**
25 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by,**
26 **Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the**
27 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat.984).**
