

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing Tohono O'odham Ki:Ki Association to Submit a 2023 Indian Community Development Block Grant Application for Construction of Community Fitness Center and Splash Pad Complex in the Chukut Kuk District San Miguel Community)

RESOLUTION NO. 23-303

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the power to enact laws "to promote, protect and provide for public health, peace,**
3 **morals, education and general welfare of the Tohono O'odham Nation and its**
4 **members" (Constitution, Article VI, Section 1(c)(2)); and**

5 **WHEREAS, the Tohono O'odham Ki:Ki Association ("TOKA") is the Nation's tribally**
6 **designated housing entity in accordance with the Native American Housing**
7 **Assistance and Self-Determination Act of 1996, 25 U.S.C. § 4101, et seq., P.L. 104-**
8 **330, 110 Stat. 4106 ("NAHASDA") and is authorized to receive and administer the**
9 **Indian Housing Block Grant ("ICDBG") and to seek other funds to operate and**
10 **expand affordable housing; and**

11 **WHEREAS, the Notice of Funding Opportunity requires applications include a current tribal**
12 **resolution confirming compliance with ICDBG Citizen Participation**
13 **requirements of 24 CFR §1003.604; and**

14 **WHEREAS, the Nation held public meetings to discuss the ICDBG program and eligible**
15 **activities including the proposed project and allowed public comments and**
16 **made modifications to the application as necessary in compliance with 24 CFR**
17 **§1003.604(a); and**

18 **WHEREAS, TOKA wishes to provide public facilities that complement and support affordable**
19 **housing for its members by submitting a 2023 ICDBG application for a public**
20 **facility consisting of a Fitness Center and Splash Pad Complex for the maximum**
21 **grant amount of \$4,000,000 and to leverage those funds with \$675,000 of 2025**
22 **Indian Housing Block Grant funds and \$675,000 of 2026 Indian Housing Block**
23 **Grant funds.**

24 **WHEREAS, the Housing Committee has reviewed the 2023 ICDBG application and**
25 **recommends its approval.**

26 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 27 **(1) TOKA is authorized to submit a 2023 application for ICDBG funding in the**
28 **amount of \$4,000,000 and leverage those funds with \$675,000 of 2025 Indian**
29 **Housing Block Grant funds and \$675,000 of 2026 Indian Housing Block**
30 **Grant funds to construct a Fitness Center and Splash Pad Complex in the**

1 Chukut Kuk District San Miguel Community that will support and
2 supplement affordable housing; and

3 (2) the Nation confirms compliance with the ICDBG Citizen Participation
4 requirements of 24 CFR §1003.604.

5 **BE IT FINALLY RESOLVED** that the Tohono O'odham Legislative Council authorizes and directs
6 the Nation's chairperson to execute all documents necessary for TOKA to submit
7 the 2023 ICDBG application for funding and any documents that may require the
8 chairperson's signature post award, including the environmental review.

9 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH
10 day of AUGUST 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;
11 -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by,
12 Article VI, Section 1(c)(2) of the Constitution of the Tohono O'odham Nation, adopted by the
13 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
14 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
15 18, 1934 (48 Stat.984).




