

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Schuk Toak District San Pedro Community Budget Amendment No. 1)

RESOLUTION NO. 23-319

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only
6 by a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2023 Schuk Toak District Budget in the amount of \$3,932,391.66 was
13 authorized by Schuk Toak District Council Resolution No. ST-08-29-22-085 and
14 approved by Legislative Council Resolution No. 22-355 and subsequently
15 amended by Resolution No. 23-087; and

16 **WHEREAS,** by the Schuk Toak District Council Resolution No. ST-07-08-23-063, the Schuk
17 Toak District has authorized and submitted for review and approval its FY 2023
18 San Pedro Community Budget Amendment No. 1, which is incorporated by this
19 reference and which will adjust operational and/or personnel line items; and

20 **WHEREAS,** the FY 2023 Schuk Toak District San Pedro Community Budget Amendment No. 1
21 will not change the FY 2023 San Pedro Community Budget amount of \$85,000.00;
22 and

23 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2023 Schuk Toak District
24 San Pedro Community Budget Amendment No. 1 and recommends its approval.

25 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
26 FY 2023 Schuk Toak District San Pedro Community Budget Amendment No. 1
27 effective October 1, 2022, which does not change the FY 2023 San Pedro
28 Community Budget amount of \$85,000.00 nor the FY 2023 Schuk Toak District
29 Budget amount of \$3,932,391.66.

30 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2023 Schuk
31 Toak District Budget as amended shall be managed and expended in accordance
32 with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and
33 the Nation's laws, provided that any amendments or modifications shall be

1 authorized under District Council resolution and submitted for prior approval by
2 the Tohono O'odham Legislative Council.

3 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH
4 day of AUGUST 2023 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;
5 -0- AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by,
6 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
7 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
8 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934
9 (48 Stat.984).


