RESOLUTION NO. 23-332

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members**
3 **(Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and**
4 **Article VI, Section 1(h)); and**

5 **WHEREAS, pursuant to Article VI and VII of the Nation's Enrollment Ordinance, the**
6 **Enrollment Committee shall review membership applications and make a**
7 **written recommendation to the Tohono O'odham Legislative Council to approve**
8 **or reject the application (14 Tohono O'odham Code Chapter 1); and**

9 **WHEREAS, pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono**
10 **O'odham Legislative Council shall determine eligibility for membership or**
11 **adoption (14 Tohono O'odham Code Chapter 1); and**

12 **WHEREAS, the Enrollment Program has received official documents reflecting the legal**
13 **name changes of enrolled members as a result of marriage, divorce, legal**
14 **adoption, or for other reasons; and**

15 **WHEREAS, the Enrollment Committee recommends that Resolution Nos. 138-81, 67-82, 136-**
16 **82, 40-84, 66-89, 93-402, 99-475, 99-561, 07-112, 10-103, 11-033, 11-502, 17-579, 18-**
17 **350, 19-223, and 22-125 be amended to reflect the legal names changes of**
18 **members identified in the September 2023 Legal Enrollment Resolution**
19 **Summary, which is incorporated by this reference.**

20 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**
21 **Nos. 138-81, 67-82, 136-82, 40-84, 66-89, 93-402, 99-475, 99-561, 07-112, 10-103, 11-**
22 **033, 11-502, 17-579, 18-350, 19-223, and 22-125 are amended upon the effective**
23 **date of those resolutions to reflect the legal name changes of members identified**
24 **in the September 2023 Legal Enrollment Resolution Summary.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH**
26 **day of SEPTEMBER 2023 at a meeting at which a quorum was present with a vote of 3,005.7 FOR;**
27 **~~0~~ AGAINST; ~~0~~ NOT VOTING; and 257.6 [05] ABSENT, pursuant to the powers vested in the**
28 **Council by, Article II, Section 1 and 2 and Article VI, Section 1(h) of the Constitution of the**
29 **Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and**
30 **approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,**
31 **1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**




