

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2024 Attorney Contract between Sonosky, Chambers, Sachse,
Miller & Monkman, LLP and Tohono O'odham Nation Health Care)

RESOLUTION NO. 23-339

1 **WHEREAS, the Tohono O'odham Legislative Council vests the Legislative Council with the**
2 **power to "employ legal counsel for the protection and advancement of the rights**
3 **of the Tohono O'odham Nation" (Constitution of the Tohono O'odham Nation,**
4 **Article VI, Section 2(a)); and**

5 **WHEREAS, Tohono O'odham Nation Health Care ("TONHC") has prepared and submitted for**
6 **review and approval the FY 2024 Attorney Contract ("Attorney Contract") between**
7 **Sonosky, Chambers, Sachse, Miller & Monkman, LLP and TONHC for the purposes**
8 **and for the amount indicated in attached Exhibit A, incorporated herein by**
9 **reference; and**

10 **WHEREAS, fees for services for this Attorney Contract will be paid by the FY 2024 TONHC**
11 **budget; and**

12 **WHEREAS, the Health & Human Services Committee has reviewed the Attorney Contract and**
13 **recommends its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:**

- 15 **1. Approves the FY 2024 Attorney Contract between Sonosky, Chambers,**
16 **Sachse, Miller & Monkman, LLP and Tohono O'odham Nation Health Care,**
17 **which shall be funded from TONHC's budget and shall be effective from**
18 **October 1, 2023, to September 30, 2024.**
- 19 **2. Authorizes the Tohono O'odham Nation Chairperson to execute the one**
20 **Attorney Contract in substantially the form attached.**
- 21 **3. Authorizes the Chief Executive Officer of TONHC or any designated official**
22 **to administer the Attorney Contract, provided that any amendments or**
23 **modifications shall be submitted for prior approval by the Tohono**
24 **O'odham Nation Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH**
26 **day of SEPTEMBER 2023 at a meeting at which a quorum was present with a vote of 3,005.7 FOR;**
27 **-0- AGAINST; -0- NOT VOTING; and 257.6 [04] ABSENT, pursuant to the powers vested in the**
28 **Council by, Article VI, Sections 2(a) of the Constitution of the Tohono O'odham Nation, adopted**
29 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
30 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
31 **Act of June 18, 1934 (48 Stat.984).**




