

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023-FY 2024 Legislative Branch Magdalena Visitor Center
Project Budget Amendment No. 1)**

RESOLUTION NO. 23-343

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2023-FY 2024 Legislative Branch Magdalena Visitor Center Project Budget
8 in the amount of \$24,000.00 was approved by Legislative Council Resolution No.
9 23-328; and

10 **WHEREAS,** the Legislative Branch has prepared and submitted for review and approval its FY
11 2023-FY 2024 Legislative Branch Magdalena Visitor Center Project Budget
12 Amendment No. 1, which is incorporated by this reference, and which will adjust
13 operational and/or personnel line items; and

14 **WHEREAS,** the FY 2023-FY 2024 Legislative Branch Magdalena Visitor Center Project Budget
15 Amendment No. 1 will increase the total FY 2023-FY 2024 Legislative Branch
16 Magdalena Visitor Center Project Budget by \$5,000.00 from \$24,000.00 to
17 \$29,000.00; and

18 **WHEREAS,** the Cultural Preservation and Budget and Finance Committees have reviewed the
19 FY 2023-FY 2024 Legislative Branch Magdalena Visitor Center Project Budget
20 Amendment No. 1 and recommend its approval.

21 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
22 FY 2023-FY 2024 Legislative Branch Magdalena Visitor Center Project Budget
23 Amendment No. 1, effective August 1, 2023 through December 30, 2023, which
24 includes a \$5,000.00 increase from \$24,000.00 to \$29,000.00 that shall be funded
25 by the Nation's general fund.

26 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Legislative
27 Council chairperson or any designated official is authorized to administer and
28 expend the FY 2023-FY 2024 Legislative Branch Magdalena Visitor Center Project
29 Budget, as amended, provided that any modifications shall be submitted to the
30 Budget and Finance Committee for approval on behalf of the Legislative Council
31 and any amendments shall be submitted for prior approval by the Tohono
32 O'odham Legislative Council.
