9	WHEREAS,	the Hewel Ni'ok Program has prepared and submitted for review and approval its
10		FY 2023 Hewel Ni'ok Administration Budget Amendment No. 1, which is
11		incorporated by this reference and which will adjust personnel line items; and
12	WHEREAS, tl	ne FY 2023 Hewel Ni'ok Administration Budget Amendment No. 1 will decrease the
13		original budgeted amount by \$23,683.72 from \$661,970.30 to \$638,286.58; and
14	WHEREAS, th	e Cultural Preservation and Budget and Finance Committees have reviewed the FY
15		2023 Hewel Ni'ok Administration Budget Amendment No. 1 and recommend its
16		approval.
17	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
18		FY 2023 Hewel Ni'ok Administration Budget Amendment No. 1 effective October 1,
19		2022, which will decrease the original budgeted amount by \$23,683.72 from
20		\$661,970.30 to \$638,286.58 and will be funded by the Nation's general fund.
