

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2023 Hewel Ni'ok KWAK-LP Budget Amendment No. 1)**

**RESOLUTION NO. 23-346**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2023 Hewel Ni'ok KWAK-LP Budget in the amount of \$292,220.60 was**  
8 **approved by Resolution No. 22-295; and**

9 **WHEREAS, the Hewel Ni'ok Program has prepared and submitted for review and approval its**  
10 **FY 2023 Hewel Ni'ok KWAK-LP Budget Amendment No. 1, which is incorporated by**  
11 **this reference and which will adjust personnel line items; and**

12 **WHEREAS, the FY 2023 Hewel Ni'ok KWAK-LP Budget Amendment No. 1 will decrease the**  
13 **original budgeted amount by \$1,060.10 from \$292,220.60 to \$ 291,160.50; and**


14 **WHEREAS, the Cultural Preservation and Budget and Finance Committees have reviewed the**  
15 **FY 2023 Hewel Ni'ok KWAK-LP Budget Amendment No. 1 and recommend its**  
16 **approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
18 **FY 2023 Hewel Ni'ok KWAK-LP Budget Amendment No. 1 effective October 1, 2022,**  
19 **which will decrease the original budgeted amount by \$1,060.10 from \$ 292,220.60**  
20 **to \$ 291,160.50 and will be funded by the Nation's general fund.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
22 **Nation chairperson or any designated official is authorized to administer and**  
23 **expend the FY 2023 Hewel Ni'ok KWAK-LP Budget as amended, provided that any**  
24 **further amendments or modifications shall be submitted for prior approval by**  
25 **the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup>**  
27 **day of SEPTEMBER 2023 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;**  
28 **-0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
29 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**  
30 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
32 **18, 1934 (48 Stat.984).**
