

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Department of Health and Human Services Division of Family
Assistance USDA Food Distribution Second Year Budget)

RESOLUTION NO. 23-357

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d) (2)); and**

7 **WHEREAS, the Department of Health and Human Services Division of Family Assistance has**
8 **prepared and submitted for review and approval its FY 2023 United States**
9 **Department of Agriculture ("USDA") Food Distribution Second Year Budget,**
10 **which is incorporated by this reference, in the amount of \$29,404.77 to be funded**
11 **from the Nation's general fund pending reimbursement from the grantor, the**
12 **USDA; and**

13 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
14 **reviewed the FY 2023 Department of Health and Human Services Division of**
15 **Family Assistance USDA Food Distribution Second Year Budget and recommend**
16 **its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
18 **FY 2023 Department of Health and Human Services Division of Family Assistance**
19 **USDA Food Distribution Second Year Budget effective October 1, 2022, in the**
20 **amount of \$29,404.77 which shall be funded by the Nation's general fund pending**
21 **reimbursement from the grantor, the USDA.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
23 **Nation chairperson or any designated official is authorized to administer and**
24 **expend the FY 2023 Department of Health and Human Services Division of Family**
25 **Assistance USDA Food Distribution Second Year Budget, provided that any**
26 **amendments or modifications shall be submitted for prior approval by the**
27 **Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH**
29 **day of SEPTEMBER 2023 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;**
30 **-0- AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**
31 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
34 **18, 1934 (48 Stat.984).**
