RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Appointing Deola Juan to the Tohono O'odham Judicial Court)

RESOLUTION NO. 23-358

1	WHEREAS,	the Tohono O'odham Legislative Council is vested with the power to appoint
2		judges to the Tohono O'odham Judicial Court pursuant to the Constitution of the
3		Tohono O'odham Nation, which states, "[t]he Tohono O'odham Courts shall be
4		courts of record and shall consist of at least six (6) judges appointed by the Tohono
5		O'odham Council" (Constitution, Article VIII, Section 3); and
6	WHEREAS,	the Constitution requires the judges' terms to be staggered so that approximately
7		one-third of the judges are appointed every other year (Constitution, Article VIII,
8		Section 4); and
9	WHEREAS,	6 Tohono O'odham Code Chapter 1 provides in part that "a candidate for Judicial
10		Court judge who does not possess a juris doctorate but possesses a bachelor's
11		degree shall have at least six years of work experience and training in a judicial
12		or law-related field which provides the desired knowledge, skills and abilities"
13		(Section 1103(C)(3)(b)); and
14	WHEREAS,	6 Tohono O'odham Code Chapter 1 further provides that "[t]rial court judges shall
15		serve six-year terms, provided that an appointment to fill a vacancy occurring
16		before the expiration of a term shall be made only for the remaining balance of
17		that term" (Section 1103(A)); and
18	WHEREAS,	candidate Deola Juan has applied for appointment to the Tohono O'odham
19		Judicial Court, possesses a bachelor's degree, has at least six years of work
20		experience and training in a judicial or law-related field, and is an enrolled
21		member of the Tohono O'odham Nation; and
22	WHEREAS,	the Judiciary Committee, having legislative oversight of matters pertaining to the
23		Tohono O'odham Judicial Court, has reviewed Deola Juan's application and
24		background information, and has interviewed Deola Juan; and
25	WHEREAS,	the Legislative Council has likewise interviewed candidate Deola Juan and
26		reviewed her application materials and background investigation report.
27	NOW, THERE	FORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it appoints
28		Deola Juan as a Tohono O'odham Judicial Court judge for a term beginning on the
29		effective date of this resolution and ending January 31, 2029, provided that she
30		shall continue to discharge the duties of the office until a successor is appointed
31		and sworn in if she satisfies the requirements of 6 Tohono O'odham Code Chapter
32		1, Section 1103 (C)(2) and (3).
