13	WHEREAS,	by the Schuk Toak District Council Resolution No. ST-07-25-23-071, the Schuk
14		Toak District has authorized and submitted for review and approval its FY 2023
15		Schuk Toak District Administration Budget Amendment No. 1, which is
16		incorporated by this reference and which will adjust operational and/or
17		personnel line items; and
18	WHEREAS,	the FY 2023 Schuk Toak District Administration Budget Amendment No. 1 will not
19		change the FY 2023 Schuk Toak District Administration Budget amount of
20		\$2,604,460.19; and
21	WHEREAS,	the Budget and Finance Committee has reviewed the FY 2023 Schuk Toak District
