

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2024 Chukut Kuk District Budget)**

**RESOLUTION NO. 23-364**

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**  
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**  
4 **authorized under resolutions of the district council and approved by the**  
5 **Tohono O'odham Council. The management of these funds shall be only by**  
6 **a treasurer or other authorized officer of the district council who has**  
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**  
8 **O'odham Nation, and all expenditures of these funds shall be by checks**  
9 **signed by such treasurer or other authorized officer and the chairman or**  
10 **vice chairman of the district council.**

11 **; and**

12 **WHEREAS, by Chukut Kuk District Council Resolution No. 2023-25, the Chukut Kuk District**  
13 **has authorized the FY 2024 Chukut Kuk District Budget, which is incorporated by**  
14 **this reference, in the amount of \$2,792,116.12; and**

15 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2024 Chukut Kuk District**  
16 **Budget and recommends its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
18 **FY 2024 Chukut Kuk District Budget effective October 1, 2023 in the amount of**  
19 **\$2,792,116.12, which shall be funded by:**

20 **(1) August 2023 District Gaming Allocation in the amount of \$2,661,949.13;**  
21 **and**

22 **(2) Carryover funds in the amount of \$130,166.99, which shall provide**  
23 **supplemental funding for the FY 2024 Tecolote Community Budget, and**  
24 **which carryover funds shall consist of FY 2016 mining carryover funds in**  
25 **the amount of \$11,467.44 and FY 2023 carryover funds in the amount of**  
26 **\$118,699.55.**

27 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves the transfer**  
28 **of the remaining August 2023 Chukut Kuk District Gaming Allocation in the**  
29 **amount of \$2,711,256.60 to the Chukut Kuk District savings account provided that**  
30 **any expenditure of these funds shall be subject to a budget authorized by the**  
31 **Chukut Kuk District Council and approved by Legislative Council resolution.**

32 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2024 Chukut**  
33 **Kuk District Budget shall be managed and expended in accordance with Article**

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18<sup>TH</sup> day of SEPTEMBER 2023 at a meeting at which a quorum was present with a vote of 3,263.3 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
