The management of these funds shall be only by a treasurer or other authorized officer of the district council who has 6 7 furnished a surety bond satisfactory to the treasurer of the Tohono 8 O'odham Nation, and all expenditures of these funds shall be by checks 9 signed by such treasurer or other authorized officer and the chairman or 10 vice chairman of the district council. 11 : and 12 WHEREAS. by Sells District Council Resolution No. SD-104-23, the Sells District has 13 authorized the FY 2024 Sells District Administration Budget in the amount of 14 \$4,713,205.73 and the FY 2024 'Sells District Economic Development Board 15 Budget in the amount of \$82,782.81, which are both incorporated by these 16 references; and 17 WHEREAS. by Sells District Council Resolution No. SD-102-23, the Sells District Council has 18 authorized the FY 2024 Sells District Communities Budget, which is incorporated 19 by this reference in the amount of \$660,000.00; and 20 WHEREAS. the Budget and Finance Committee has reviewed the FY 2024 Sells District 21 Administration Budget, FY 2024 Sells District Economic Development Board 22 Budget, and the FY 2024 Sells District Communities Budget and recommends 23 their approval. 24 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 25 FY 2024 Sells District Administration Budget and the FY 2024 Sells District 26 Communities Budget effective October 1, 2023 in the total amount of 27 \$5,373,205.73, which shall be funded by the August 2023 District Gaming 28 Allocation. 29 BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves the FY 2024 30 Sells District Economic Development Board Budget effective October 1, 2023 in 31 the amount of \$82,782.81, which shall be funded by the Sells District Economic
