15	WHEREAS,	the Budget and Finance Committee has reviewed the FY 2024 San Xavier District
16		Budget and recommends its approval.
17	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
18		FY 2024 San Xavier District Budget, effective October 1, 2023, in the amount of
19		\$9,670,463.33, which shall be funded by:
20		1. August 2023 District Gaming Allocation funds in the amount of
21		\$8,878,651.90.
22		2. August 2023 District Mining Allocation funds - Cyprus Mine in the amount
23		of \$179,691.35;
24		3. ASARCO lease proceeds in the amount of \$3,732.86;
25		4. Grant funds in the amount of \$453,090.72; and
26		5. District Operating Account funds in the amount of \$155,296.50.
