13	authorized the FY 2024 Gu-Vo District Budget, which is incorporated by this							
14		reference, in the amount of \$5,529,425.24; and						
15	WHEREAS,	the Budget and Finance Committee has reviewed the FY 2024 Gu-Vo District						
16		Budget and recommends its approval.						
17	NOW, THERI	EREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the						
18		FY 2024 Gu-Vo District Budget effective October 1, 2023 in the amount of						
19		\$5,529,425.24, which shall be funded as follows:						
20		1. August 2023 District Gaming Allocation in the amount of \$5,373,205.73;						
21		2. FY 2015 Ali Chugk Community carryover funds in the amount of						
22		<b>\$54,966.02</b> ;						
23		3. FY 2016 Ali Chugk Community carryover funds in the amount of						
24		\$56,464.29; and						
25		4. FY 2017 Ali Chugk Community carryover funds in the amount of						
26		\$44,789.20.
