The management of these funds shall be only by 6 a treasurer or other authorized officer of the district council who has 7 furnished a surety bond satisfactory to the treasurer of the Tohono 8 O'odham Nation, and all expenditures of these funds shall be by checks 9 signed by such treasurer or other authorized officer and the chairman or 10 vice chairman of the district council. 11 ; and 12 WHEREAS. by San Lucy District Council Resolution No. SL 08-177-23, the San Lucy District has 13 authorized the FY 2024 San Lucy District Budget, which is incorporated by this 14 reference, in the amount of \$15,539,425.69; and 15 WHEREAS, the Budget and Finance Committee has reviewed the FY 2024 San Lucy District 16 Budget and recommends its approval. 17 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 18 FY 2024 San Lucy District Budget effective October 1, 2023 in the amount of 19 \$15,539,425.69, which shall be funded by: 20 August 2023 District Gaming Revenue Allocation in the amount of **(1)** 21 \$12,257,230.48; 22 FY 2023 District Mining Allocation in the amount of \$179,691.35; and **(2)** 23 (3) FY 2023 carryover funds in the amount of \$3,102,503.86. 24 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2024 San Lucy 25 District Budget shall be managed and expended in accordance with Article IX. 26 Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws, 27 provided that any amendments or modifications shall be authorized under 28 District Council resolution and submitted for prior approval by the Tohono 29 O'odham Legislative Council. 30 31 32
