3		O'odham Nation and its members" and with the authority "to consult with the
4		Congress of the United States and appropriate federal agencies regarding federal
5		activities that affect the Tohono O'odham Nation" (Constitution, Article VI,
6		Section 1(c)(2) and Section 1(j)); and
7	whereas,	the National Indian Health Board ("NIHB"), established in 1972, serves all
8		Federally recognized American Indian and Alaska Native tribal governments by
9		advocating for the improvement of health care delivery to American Indians and
10		Alaska Natives; and
11	WHEREAS,	the NIHB is governed by a Board of Directors consisting of representatives elected
12		by the American Indian and Alaska Native tribal governments in each of the 12
13		Indian Health Service ("IHS") areas; and
14	WHEREAS,	the NIHB has designated the Nation as a member of the Tucson Area and the
15		Nation has previously appointed representatives and alternates to the NIHB; and
16	WHEREAS,	by Resolution No. 23-082, the Legislative Council nominated Representative
17		Delma M. Garcia as Tucson Area representative on the NIHB and Representative
18		Daniel L.A. Preston, III as alternate; and
19	WHEREAS,	the Health and Human Services Committee recommends the nomination of
20		Representative Pamela J. Benavidez for appointment as the Tucson Area
21		representative on the NIHB and reaffirms the appointment of Representative
22		Daniel L.A. Preston, III as alternate.
23	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council nominates
24		Representative Pamela J. Benavidez for appointment as the Tucson Area
25		representative on the National Indian Health Board and reaffirms the
26		appointment of Representative Daniel L.A. Preston, III as alternate.
27	BE IT FINALI	LY RESOLVED by the Tohono O'odham Legislative Council that any appointment
28		made pursuant to this resolution shall immediately expire if the appointed
29		representative no longer serves on the Health and Human Services Committee for
30		any reason.
