15		Representative Marietta Martin as alternate; and				
16	WHEREAS,	Representative Marietta Martin no longer serves on the Legislative Council; and				
17	WHEREAS,	the Health and Human Services Committee reaffirms the appointment of				
18		Representative Daniel L.A. Preston, III as the TTAG Tucson Area representative				
19		and recommends the nomination of Representative Pamela J. Benavidez as				
20		alternate.
