

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting Institute of Museum and Library Services Native American Library Services
Basic Grant and Approving FY 2024 Department of Education Institute of Museum
and Library Services Native American Library Services Basic Grant Budget)

RESOLUTION NO. 23-394

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham Legislative Council is authorized to "adopt, approve and**
8 **amend annual budgets and to authorize the expenditure of funds in accordance**
9 **with these budgets (Constitution of the Tohono O'odham Nation, Article VI**
10 **Section 1(d)(3));**

11 **WHEREAS, the Department of Education Venito Garcia Library has applied for and received**
12 **the Native American Library Services Basic Grant Award No. NAB-254817- OLS-23**
13 **in the amount of \$10,000.00 from the Institute of Museum and Library Services**
14 **("IMLS") Native American Library Services; and**

15 **WHEREAS, the Department of Education has prepared and submitted for review and**
16 **approval its FY 2024 Department of Education IMLS Native American Library**
17 **Services Basic Grant Budget, which is incorporated by this reference, in the**
18 **amount of \$10,000.00 to be funded by the Nation's general fund pending**
19 **reimbursement from the Institute of Museum and Library Services ("IMLS")**
20 **Native American Library Services; and**

21 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
22 **reviewed the FY 2024 Department of Education IMLS Native American Library**
23 **Services Basic Grant Budget and recommend its approval.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts the**
25 **Institute of Museum and Library Services Native American Library Services Basic**
26 **Grant Award No. NAB-254817-OLS-23 and approves the FY 2024 Department of**
27 **Education IMLS Native American Library Services Basic Grant Budget effective**
28 **August 1, 2023, ending on July 31, 2024, in amount of \$10,000.00, which shall be**
29 **funded by the Nation's general fund pending reimbursement from the Institute**
30 **of Museum and Library Services Native American Library Services.**



2 Nation chairperson or any designated official is authorized to administer and
3 expend the FY 2024 Department of Education IMLS Native American Library
4 Services Basic Grant Budget, provided that any amendments or modifications
5 shall be submitted for prior approval by the Tohono O'odham Legislative Council.

6 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09th
7 day of OCTOBER 2023 at a meeting at which a quorum was present with a vote of 3,263.3 FOR; -0-
8 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
9 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by
10 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
11 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
12 18, 1934 (48 Stat.984).




