

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2023 Planning and Economic Development Department Roads  
Program Cowlic Road Project Budget Amendment No. 3)**

**RESOLUTION NO. 23-403**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2023 Planning and Economic Development Department Roads Program  
8 Cowlic Road Project ("Project") in the amount of \$1,107,512.08 was approved by  
9 Resolution No. 21-328; and

10 **WHEREAS,** Legislative Council approved Amendment No. 1 to the Project in Resolution No.  
11 22-422, which increased the budget by \$2,999,243.00 to \$4,106,755.08; and

12 **WHEREAS,** Legislative Council approved Amendment No. 2 to the Project in Resolution No.  
13 23-059, which increased the budget by \$5,000,000.00 to \$9,106,755.08; and

14 **WHEREAS,** the Planning and Economic Development Department Roads Program has  
15 prepared and submitted for review and approval FY 2023 Cowlic Road Project  
16 Budget Amendment No. 3, which is incorporated by this reference and will adjust  
17 operational line items; and

18 **WHEREAS,** the Planning and Economic Development Department Roads Program will  
19 increase the FY 2023 Cowlic Road Project Budget by \$3,872,597.94 from  
20 \$9,106,755.08 to \$12,979,353.02 and shall be funded by the Nation's general fund  
21 pending reimbursement from the grantor, the Bureau of Indian Affairs; and

22 **WHEREAS,** the Agricultural and Natural Resources and Budget and Finance Committees  
23 have reviewed the FY 2023 Planning and Economic Development Department  
24 Road Program Cowlic Road Project Amendment No. 3 and recommend its  
25 approval.

26 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
27 **FY 2023 Planning and Economic Development Department Roads Program**  
28 **Cowlic Road Project Budget Amendment No. 3 effective October 1, 2022 to**  
29 **September 30, 2025, which includes a \$3,872,597.94 increase from \$9,106,755.08**  
30 **to \$12,979,353.02 that shall be funded by the Nation's general fund pending**  
31 **reimbursement from the grantor, the Bureau of Indian Affairs.**

**BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation chairperson or any designated official is authorized to administer and expend the FY 2023 - 2025 Planning and Economic Development Department Roads Program Cowlic Road Project Budget Amendment No. 3 as amended, provided that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.**

**The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup> day of OCTOBER 2023 at a meeting at which a quorum was present with a vote of 3,263.3 FOR; -0- AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**


