

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 22-107 "Approving Tohono O'odham Nation
Healthcare FY 2023 American Rescue Plan Act Lost Reimbursement
Budget" to extend the Budget Authority into FY 2024)**

RESOLUTION NO. 23-404

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2) and (3)); and**

7 **WHEREAS, the FY 2023 Tohono O'odham Nation Healthcare American Rescue Plan Act Lost**
8 **Reimbursement Budget in the amount of \$19,034,930.00 was approved by**
9 **Resolution No. 22-107; and**

10 **WHEREAS, the FY 2023 Tohono O'odham Nation Healthcare American Rescue Plan Act Lost**
11 **Reimbursement Budget was amended by resolution No. 23-019; and**

12 **WHEREAS, Tohono O'odham Nation Health Care is requesting the budget term be extended**
13 **for the FY 2024 American Rescue Plan Act Lost Reimbursement Budget in amount**
14 **of \$19,034,930.00, which expires on September 30, 2023, into FY 2024 to expend**
15 **available funds; and**

16 **WHEREAS, Tohono O'odham Nation Health Care with the amendment will also be creating**
17 **one new line item, 7500 Capital Equipment; and**

18 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
19 **reviewed the FY 2024 American Rescue Plan Act Lost Reimbursement Budget**
20 **amending resolution and recommend its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council amends**
22 **Resolution No. 22-107 to extend the budget authority for the FY 2024 Tohono**
23 **O'odham Nation Healthcare American Rescue Plan Act Lost Reimbursement**
24 **Budget in the amount of \$19,034,930.00, effective October 1, 2021, and ending**
25 **September 30, 2024.**

26 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves the creating**
27 **of one new line item, 7500 Capital Equipment.**

28 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
29 **Nation chairperson or any designated official is authorized to administer and**
30 **expend the FY 2024 Tohono O'odham Nation Healthcare American Rescue Plan**
31 **Act Lost Reimbursement Budget as amended, provided that any amendments or**

modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH day of OCTOBER 2023 at a meeting at which a quorum was present with a vote of 3,263.3 FOR; -0- AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
