

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Enrollment Resolution Nos. 222-84, 423-90, 94-459, 99-004, 05-368,  
and 15-431 to Reflect Legal Name Changes of Enrolled Members)**

**RESOLUTION NO. 23-409**

1   **WHEREAS,**    the Tohono O'odham Legislative Council is vested with the power to enact laws  
2                   and ordinances governing the enrollment and adoption of members  
3                   (Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and  
4                   Article VI, Section 1(h)); and

5   **WHEREAS,**    pursuant to Article VI and VII of the Nation's Enrollment Ordinance, the  
6                   Enrollment Committee shall review membership applications and make a  
7                   written recommendation to the Tohono O'odham Legislative Council to approve  
8                   or reject the application (14 Tohono O'odham Code Chapter 1 - Enrollment  
9                   Ordinance); and

10   **WHEREAS,**    pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono  
11                   O'odham Legislative Council shall determine eligibility for membership or  
12                   adoption; and

13   **WHEREAS,**    the Enrollment Program has received official documents reflecting the legal  
14                   name changes of enrolled members as a result of marriage, divorce, legal  
15                   adoption, or for other reasons; and

16   **WHEREAS,**    the Enrollment Committee recommends that Resolution Nos. 222-84, 423-90, 94-  
17                   459, 99-004, 05-368, and 15-431 be amended to reflect the legal name changes of  
18                   members identified in the November 2023 Legal Enrollment Resolution  
19                   Summary, which is incorporated by this reference.

20   **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that Resolution  
21                   Nos. 222-84, 423-90, 94-459, 99-004, 05-368, and 15-431 are amended upon the  
22                   effective date of those resolutions to reflect the legal name changes of members  
23                   identified in the November 2023 Amended Enrollment Resolution Summary.

24   **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup>**  
25   **day of NOVEMBER 2023 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;**  
26   **~~-0-~~ AGAINST; ~~-0-~~ NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
27   **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham**  
28   **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**  
29   **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**  
30   **16 of the Act of June 18, 1934 (48 Stat.984).**
