6		making recommendations to the Legislative Council regarding the eligibility of			
7		applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and			
8	WHEREAS,	the Enrollment Program has determined that a member was originally approved			
9		for membership by Resolution No. 07-739; and			
10	WHEREAS,	the Enrollment Program discovered that this same member was mistakenly			
11	,	approved a second time for membership by Resolution No. 08-330; and			
12	WHEREAS,	the Enrollment Program therefore recommends that Resolution No. 08-330 be			
13		amended to delete the member identified in the attached Amending Enrollment			
14		Resolution List November 2023; and			
15	WHEREAS,	the member that was originally approved in Resolution No. 07-739 will retain the			
16		roll number and approval date identified in that resolution.
