

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Certification of and Distribution to A Tohono O'odham Nation Eligible  
Adult Member for the Fourth Per Capita Distribution for November 2023)**

**RESOLUTION NO. 23-418**

1 **WHEREAS, on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the**  
2 **"O'odham Voice on Use of Gaming Revenues" (the "Initiative"), which authorizes**  
3 **per capita payments to the Nation's members provided that sufficient gaming**  
4 **revenues are available; and**

5 **WHEREAS, the Ordinance for the Regulation of Gaming Activities Within the Tohono**  
6 **O'odham Nation (the "Gaming Ordinance") was subsequently amended to**  
7 **authorize per capita distribution payments in accordance with the Initiative**  
8 **(Legislative Council Resolution No. 97-303); and**

9 **WHEREAS, the Legislative Council did adopt the Tohono O'odham Nation Revenue Allocation**  
10 **Plan pursuant to Legislative Council Resolution No. 09-164; and**

11 **WHEREAS, on June 15, 2009, the Nation received notice from the Department of Interior that**  
12 **the Tohono O'odham Nation Revenue Allocation Plan was approved; and**

13 **WHEREAS, the Tohono O'odham Nation Department of Membership Services submitted to**  
14 **the Tohono O'odham Legislative Council the Master List for Eligible Adult Tohono**  
15 **O'odham Members for the Fourth Per Capita Distribution ("Master List") for**  
16 **review and approval; and**

17 **WHEREAS, Legislative Council approved the Master List with the initial number of 19,141**  
18 **verified adult members (Resolution Number 09-428); and**

19 **WHEREAS, the disbursement of funds to each eligible adult member is contingent upon**  
20 **verification of a member and certification by the Tohono O'odham Legislative**  
21 **Council; and**

22 **WHEREAS, the Tohono O'odham Department of Membership Services has submitted a**  
23 **certification list of one verified adult member who is listed on the previously**  
24 **approved Master List and is eligible to receive the fourth per capita payment.**

25 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 26 **1. Approves the verification and certification of the adult member listed on the**  
27 **attached November 2023 Certification Listing of An Adult Member for the**  
28 **Fourth Per Capita Distribution.**
- 29 **2. Approves the distribution of \$2,000, less any applicable taxes required by**  
30 **federal law, to the adult member listed.**
- 31 **3. Authorizes the Chairperson of the Nation or a designated official to execute**  
32 **such other documents as may be necessary to implement this resolution.**



2 **disbursement of funds to additional eligible Tohono O'odham adult**  
3 **members is contingent upon verification of membership by the Tohono**  
4 **O'odham Department of Membership Services and certification by the**  
5 **Tohono O'odham Legislative Council.**

6 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup>**  
7 **day of NOVEMBER 2023 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;**  
8 **-0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
9 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
10 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
11 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
12 **18, 1934 (48 Stat.984).**




