

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2024 Department of Health and Human Services, Division of
Child Welfare Budget Amendment No. 1)

RESOLUTION NO. 23-423

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2024 Department of Health and Human Services, Division of Child Welfare**
8 **Budget in the amount of \$6,850,769.83 was approved by Resolution No. 23-192;**
9 **and**

10 **WHEREAS, the Department of Health and Human Services, Division of Child Welfare**
11 **prepared and submitted for review and approval its FY 2024 Budget Amendment**
12 **No. 1, which is incorporated by this reference, and which will adjust personnel**
13 **and operational line items but will not change the overall budget amount; and**

14 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
15 **reviewed the FY 2024 Department of Health and Human Services, Division of**
16 **Child Welfare Budget Amendment No. 1 and recommend its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
18 **FY 2024 Department of Health and Human Services, Division of Child Welfare**
19 **Budget Amendment No. 1 effective October 1, 2023, in the amount of \$6,850,769.83**
20 **that shall be funded by the Nation's General Fund.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
22 **Nation chairperson or any designated official is authorized to administer and**
23 **expend the FY 2024 Department of Health and Human Services, Division of Child**
24 **Welfare Budget as amended, provided however, that any amendments or**
25 **modifications shall be submitted for prior approval by the Tohono O'odham**
26 **Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH**
28 **day of NOVEMBER 2023 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;**
29 **-0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat.984).**
